challenging as we won't have much time to get settled in our new home before we need to jump into our new ministries.

Along with packing our own stuff, we have kept very busy moving furniture and everything else out of the EBI-Jackson school and preparing this building for sale.



Todd's "last visit" with the realtor and prospective buyer(s) of the school was extremely encouraging. Pray they can get the funding to purchase this property – soon!

Todd has been prepping for teaching Genesis class starting September 1. A reduced number of freshmen (due to Covid/social distancing) will be living on campus. They will be split into two classes of 25-30 students. Todd will be teaching the same lesson two times each day. All the upperclassmen and married students will be returning as well. 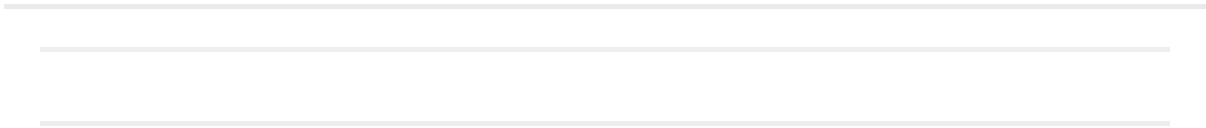
