If you have seen the news in the last 48 hours you are aware of the explosion in Beirut, Lebanon. We have people there, and they have all reported safe. However, the impact across the city and country is deep. We have learned, and have shared with many of you, that when we see this kind of devastation anywhere, our first thoughts are for those affected by the event, but very quickly we asked, what is God going to do now? Often times we have seen horrible scenes only to see God work through these to open hearts and advance what He is doing.

The events in Beirut weren't caused by God, and we can't change what happened, but we can respond. We have been interacting and helping here to set up ways to step into this situation. One of those ways is by making funds

available to our people and their partners on the ground. We have already sent an initial donation. We are now inviting others to join with Worldventure.

Here are some prayer requests:

1. Pray that Worldventure workers and believers will be strengthened as they respond.
2. Pray for the response of those who receive help. That as aid is given, people will be helped and that hearts will be open to God in new and powerful ways.
3. Pray for those of us who aren't in Beirut, but are putting things together on this end. COVID travel isn't an option, but there is still much we want to do.
