Thank you for your prayers for Marty in the crisis training last week. It was a very good time with items that we will need to implement in today's unpredictable world. More than all the training and preparation, we serve a God who knows all and can do more than we ever can.

After writing you last week, we received notice that one of our people who had served for almost three decades passed away from cancer. So after returning home on Thursday, Denise and I flew on Friday to the location to represent WorldVenture at the funeral of this servant. It was a time with many memories as Denise and I had been the supervisor for this person for about ten years. We boarded our plane on Saturday evening to fly back to Denver, only to have to get off the aircraft due to a mechanical issue. The flight was eventually

canceled, and we were rebooked the next day on very different flights. Part of our world. We did get back home, but a day later than planned.

We are asking for prayer this week as Marty leads a group of five people who will spend three days working on global missions' strategy and implementation here at WorldVenture. These will be three full days of discussions, prayer, and lots of work. The days will be long, but with God's leading, we desire to come out of our time ready to implement a global strategy. The meetings will be Tuesday (tomorrow) from noon through Thursday at 4 PM.
