Your prayers were answered! It was an intense three weeks with a great deal of travel and interaction, but thank you for your prayers.

On Saturday, Denise and I will be flying to Mozambique, where we will be for ten days. Please pray for the following during this time.

- 1. We have to have negative COVID tests.
- 2. We get the results of the tests back prior to departure. We can't board an airplane without the results. We only have 72 hours from the time of the test until we board. A lot of people are getting tests, so we are sure the labs are busy.
- 3. Good flight. That means the flights are on time and we have good connections. Four flights to get there and four flights to get back. One of our

flights is 15 hours. We also have a 12 hour layover on the way.

- 4. That our time there with meetings and with people will go very well. That God's presence and leading will be evident.
- 5. We have to have another negative COVID test prior to leaving. So pray that will be timely and negative as well.

There is a great deal of news over the last week. The Afghanistan situation is front and center. At WorldVenture we are looking at opportunities both here in the US and in other parts of the world to work with the Afghanistan refugees.
