I'll be traveling out to a remote area to have some teaching time with women there. I'll be traveling with Ps. Ganga to a district I have actually never been in. That's exciting, though more so is that there are now 3 groups in this area and very little has ever been done for the women. Most of these will be low or illiterate who have only joined within the last few years. We'll actually also do youth meetings as well, since one of the groups happens to have many high school age, but very few women. We also will be traveling close to the area of the recent

earthquakes. Thankfully there doesn't seem to have been road damage.

I've been fighting some respiratory issues this week, so do be asking for that to heal completely, for endurance for some long teaching days, and especially for Him to work in hearts to encourage, challenge, and strengthen the bodies there.
