I have been following, very closely, the news on the Ukraine situation for several weeks. Three years ago Marty taught at a seminary for a week, and those students have now graduated, are in ministry and in the midst of what is taking place there. All WorldVenture missionaries are out of the country, with some still in the region. As we go into the weekend we would like to provide you with prayer requests and ways to be involved. The events are far from over.

- 1. Pray for our WorldVenture colleagues who have left homes, ministry, and colleagues. Pray for them at this time as they adjust to an unknown future.
- 2. Pray for the WorldVenture Ukraine MKs. They process this differently, but just as intently. Ukraine is where they grew up and is home.
- Over the years, WorldVenture workers have discipled, trained, and

walked with Ukrainians in ministry all over that country and in other locations. These people are now giving spiritual leadership to people caught in the middle. Many WV people are teaching in various schools there, and the students are also in the middle of this situation and need prayer.

- 4. Pray for the churches and church plants across the country.
- 5. Pray for us as we work with leadership in the region on next steps. We anticipate that we will be giving much attention to these needs over the coming days and weeks.
