Missions Committee

I am back from Poland. The time spent there was full of long days (7:30 AM to 9:00 PM), a lot of conversations related to planning, loading up vehicles, and attending church. Your prayers were greatly appreciated.

Church this past Sunday was very special. The average attendance at the church is 50 people. Last Sunday there were over 100. People filled the worship area, the hallway, the next room, and down the stairs. Most were Ukrainians who had recently arrived in Poland. In testimonies, they shared of leaving their homes, some not knowing if their home were still standing. Their faith was strong as evidenced by their testimonies, but their futures are unknown.

We visited another church that had opened its entire church to refugees as they were very close to the border. The result was that they had to meet for Sunday services in a rented building.

There were vehicles with a variety of items heading back across the border. Food, bedding, etc.



My goal was to help the team there think through the next steps. Unlike an earthquake or tsunami, this situation is ongoing and nobody is sure when it will end, and that makes planning even more challenging. I left feeling there is so much to do, but the work is going on. Pray for the workers who are so busy every day. They will need rest along the way. Pray for the Ukrainians who have come with very little in terms of personal possessions and don't know what the future holds for them. Pray that through all of this, people will come to know Jesus, the churches will grow and be stronger.

The flights back were uneventful. Since getting back I have had connections with various people/groups about partnerships. The work continues. Your prayers are felt and so greatly appreciated.

We do appreciate our partnership with you and your prayers for us.
