I, Marty, have been planning for and fully anticipated that I would be on a plane today for Argentina. However, I am not going south, but will leave tomorrow, Thursday morning, for Poland. I will be working with WorldVenture's people there to help set-up our plan to work with all the Ukrainian refugees.

Due to my experience leading responses with multiple crises during our time in Asia I am going to help, We dealt with enough of crisses to become knowledgeable in setting up responses. One is never an expert in these events, but you learn a great deal in each one to help with the next one.

Everything is coming together, but with this sudden critical need and an abrupt change in my plans, here are some prayer requests.

1. Prayer for all of the flights and connections. Both ways.
2. Prayer for me as I will be driving a rental car in a new country.
3. Prayer for wisdom in every conversation and all of the planning.
4. Prayer that our plans will result not just in helping people's physical needs but also in seeing people come to know Jesus and walk with him.
5. Prayer for Denise as she will be remaining here.
