As a quick recap, we would be deciding whether to begin drawing a full salary now or to wait. This is a necessary step, because I will need to present several months' worth of pay stubs when I apply for my visa, and I am hoping to depart in the spring. We were concerned that I may not have enough funds in my outgoing funds to make this a wise decision at the current time. Therefore, I sent out the newsletter, and my team decided to revisit the discussion at the end of the month.



The last half of January has been quite the miserable time for me. The winter cold always causes my arthritis joint pain to flare up. The arthritis medication that I rely on the most is a monthly infusion. It was denied by my insurance; it will be figured out, but it's taking a while. Currently, I am a full two weeks past my last infusion due date. I find that I am fatigued and easily irritated. If I'm not careful, I can take my frustrations out on the people around me or I can start crying at the drop of a hat. Thankfully my family is very, very patient!

attitude through the pain. Just because I don't feel well, doesn't mean I get a
